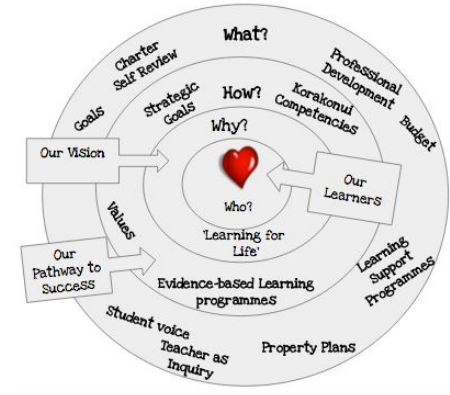


I will:

	<p>I will</p> <ul style="list-style-type: none"> <li>• Maintain and understand the values and goals of the school</li> <li>• Remember I am here for the learning and wellbeing needs of all students of Korakonui School, and not just my own</li> <li>• Follow my specific legal responsibilities under the Education Act 1989</li> <li>• Respect the integrity of the principal, staff and my fellow trustees and work to maintain a relationship centred on trust</li> <li>• Make hard decisions in the interests of our students</li> <li>• Ensure confidentiality of non-public information acquired in my role as a trustee</li> <li>• Act as a good employer</li> <li>• Ensure that we govern in a way that fulfils the intent of the treaty of Waitangi</li> </ul>
	<p>I will:</p> <ul style="list-style-type: none"> <li>• Speak with one voice beyond the door</li> <li>• Will ensure that any disagreements with the board's stance are resolved within the board</li> <li>• Work under the "no surprises" expectation</li> <li>• Remember we represent our community</li> <li>• Acknowledge and respect our differences</li> </ul>
	<p>I will:</p> <ul style="list-style-type: none"> <li>• Come prepared to all board meetings</li> <li>• Be an active board member, not a passive one</li> <li>• Conduct myself professionally as a trustee</li> </ul>
	<p>I will:</p> <ul style="list-style-type: none"> <li>• Understand that only the chair (working within the board's agreed chair role description or delegation) or a delegate working under written delegation, can speak for the board</li> <li>• Transparently share information for effective scrutiny</li> <li>• Keep asking the question, "are we doing the right thing here?"</li> <li>• Maintain the trust and confidentiality invested in me as a trustee</li> </ul>
	<p>I will:</p> <ul style="list-style-type: none"> <li>• self-monitor my own performance as a trustee against policies and any other current board evaluation tools</li> <li>• Be available to undertake appropriate professional development</li> </ul>
	<p>I will:</p> <ul style="list-style-type: none"> <li>• Be prepared to scrutinise the decisions that we make as a board</li> <li>• Keep asking the question, "what difference will this make for our students and how will we know?"</li> </ul>
